Dispute resolution

Where disputes are unavoidable, we will work with you to resolve them, by way of litigation, international arbitration or alternative dispute resolution. We are experts in handling disputes of any size involving, among other things, delay/programme and technical issues regarding oil and gas pipelines, flow stations, pump stations, compressor and meter stations. We are used to working alongside independent consultants such as programming experts, quantity surveyors and engineers on a daily basis.

As offshore oil and gas exploration has become deeper and more remote, this has raised numerous challenges for the design, fabrication and installation of marine pipelines, subsea production systems and subsea umbilicals, risers and flowlines (SURF).
